Sub: Survey on Leather & Leather Products Sector by National Productivity Council (NPC) – Questionnaire

This is to inform that the Department of Industrial Policy & Promotion, Ministry of Commerce & Industry, Government of India, has entrusted an assignment to National Productivity Council (NPC) for evaluation & appraisal of **Indian Leather Development Programme (ILDP)** being implemented under the 12th Plan period and appraise the effectiveness of existing sub-schemes of ILDP.
