

Open House Meet for IDLS Scheme being held at CLE Offices, every Wednesday

It has been stated and observed that there is considerable time gap between the date of the Sanction Letter and the claim lodged by the SIDBI Branches with the SIDBI HO. According to the SIDBI, the beneficiary units are not approaching SIDBI in time or taking longer time to complete the documentations with the SIDBI. The DIPP is urging the CLE to follow-up with the units whose cases have been approved and ensure that the units complete documentations and SIDBI Branches lodges the claims with the SIDBI HO.

Being the Facilitation Agency, the CLE plays a pivotal role in the implementation of the IDLS Scheme, and in order to have a continuous monitoring of the cases under IDLS Scheme, **it has been decided to organize an 'Open House Meet for the IDLS Scheme', every Wednesday from 10.00am to 1.00pm at all the Regional Offices at Chennai, New Delhi, Kanpur, Kolkata & Mumbai and Extension Offices at Agra & Jalandhar.**

The Regional Directors in the case of Regional Offices, and Assistant Director or Office-in-charge in the case of Extension Offices will be present in the Open House Meet to interact with the participants. Through the Video Conference Facility installed at the CLE offices, the Assistant Director (ILDIP) will take part in the Open House Meet from Head Office and will have detailed interactions with the Regional Directors on each case basis being handled in that period and would also clarify to any query raised by the participant. ROs/ EOs will prepare the Minutes and will take follow up actions with units and SIDBI. On issues concerning the DIPP, the same shall have to be intimated to the HO which will take action as deem appropriate.

The first of the Open House Meet was held on 25th September 2013. The 2nd and 3rd & 4th Open House Meets were held on 3rd Oct 2013, 9th Oct 2013 & 17th Oct 2013.

A total of 246 cases approved during the XII Plan – financial year 2012-13, were the central focus of the analysis.

Out of this, funds were disbursed / process completed for 160 cases, and SIDBI Branches already lodged claim with SIDBI HO for 22 cases. As such, there are 64 outstanding cases for which the beneficiary units have to complete the documentation process with the SIDBI Branches. The region-wise breakups of the 64 outstanding cases which are under various stages of processing are North: 33 cases, South: 16 cases. East: 5 cases, Central 9 cases, West 1 case.

Further, 50 cases approved in the 29th Steering Committee meeting under ILDP held on 28.06.2013 will also be taken up for analysis. Besides these latest cases, the outstanding cases referred by the DIPP also taken up for analysis and current status feedbacks are ascertained on case-to-case basis as per the requirement, and conveyed to the authorities concerned for their perusal.

Besides physical participation of the units, outstanding cases are also pursued over telephone and current status feedbacks are noted. A total of 39 units participated in the first Open House meet held on 25.09.2013. 26 units, 20 units & 17 units attended the meets held on 03.10.2013, 09.10.2013 & 17.10.2013 respectively.

Shri K Abdul Sattar Khan, Regional Director(South), Shri O P Pandey, Regional Director(Central), Shri Sanjay Kumar, Regional Director(North),

Shri Tapan Chattopadhyay, Regional Director(East), and Shri D K Acharya, Regional Director(West) conducted the Open House Meets at their respective Regional Offices. Shri R K Shukla, Assistant Director for Agra, conducted the meetings at Agra. Similarly, office in charge Shri Sachin Behl organized the meetings at Jalandhar

Shri A. Fayaz Ahmad, Assistant Director (ILDIP), Head Office, took part in the Open House Meets from the CLE HO through Video Conference or Mobile Phone, and made clarifications and guidance on case-to-case basis, guidelines for receipt of applications, technical and financial appraisal coordination, documentations to be completed with SIDBI etc, and held discussions with the units. Shri A. Fayaz Ahmad, Assistant Director (ILDIP) is overall monitoring the approved cases under IDLS Scheme for the purpose of submission of various reports to the DIPP, Government of India as desired by the DIPP.

Members are requested to attend the Open House Meet for IDLS Scheme, which is held every Wednesday at CLE offices. The details of the application submissions, documents required as enclosures, process to be followed with the SIDBI etc will be explained by the CLE during the open house meetings for the benefit of the industry.
