# Two Day Buyer Seller Meet in Birmingham, UK

September 28 – 29, 2015

### **About United Kingdom Market:**

he estimated population of United Kingdom is around 70 million with a strong labour force of around 4 million. The total U.K. household consumption on clothing and footwear is around Euro 60 billion. The U.K. fashion market is a leading industry well known for key players like Burberry, Marks & Spencer, Next, Top Shop, Asos, Mulberry, Super group and French Connection. The direct value of the U.K. fashion industry to the U.K. economy is £ 26 billion, up from £ 21 billion in 2009, showing an increase of 22% in nominal terms (Source: Oxford Economic 2014). Despite more than a third of consumer spending goes through shops, the online fashion market continues to boom and reached nearly £ 4.1 billion in 2009, up by 26% in 2008.

The luggage and leather goods market values the total sales of bags, wallets & purses and luggage. Bags, wallets & purses include briefcases, handbags, wallets and purses. Luggage includes suitcases and travel bags.

The total revenues of the U.K. luggage and leather goods market in 2012 was approximately USD 1,798.2

billion. The luggage segment is the most lucrative with approx. revenues of USD 1,109 billion in 2012, equivalent to 61.7% of the market's overall value. The bags, wallets and purses segment with approx. revenue of USD 689.3 billion in 2012 , contributing to 38.3% of the market's aggregate value. The footwear industry is U.K. is also very large and every year around £ 6 billion of footwear is sold in U.K. Britain is home to some of the leading footwear brands and the most innovative directional designers. There is a consistent demand of highend footwear in the United Kingdom.

# Global Trade of Leather & Leather Products and Share of U.K.:

UK is 7th largest importer of leather and leather products in the world. UK's import of leather and leather products increased from US\$ 6823.61 million in 2008 to US\$ 7646.86 million in 2012, growing at a CAGR of 2.88%. UK accounted for a share of 4.76% in the global leather import trade of US\$ 160.54 billion in 2012.

Buyer Seller Meet, Birmingham: UK is 3rd largest importer of leather and leather products from India. During 2014-15, UK accounted for a share of 11.57% in India's total leather products export of US\$ 6494.41 million. India's export of leather & leather products to UK has increased from US\$ 505.20 million in 2010-11 to US\$ 751.33 million in 2014-15, growing at a CAGR of 10.43%.

In order to tap the huge market potential in UK & to further enhance our market share in that country, a "Two Day Buyer-Seller Meet" was organized by CLE with support of Department of Commerce (under MAI Scheme) and full logistics support of Consulate General of India, Birmingham in Millennium Point, Birmingham .

CLE is actively publicizing Hon'ble Prime Minister of India's flagship programme "Make in India" at various forums and we are sure that with his forthcoming visit to United Kingdom, the initiative will achieve further momentum, paving the way for enormous investment in various segments of Indian Industries, including Leather Sector, thereby enhancing the bilateral trade between India and United Kingdom.
