- i. Designs should not be changed and adhered to as per the tender design prescribed in the tender.
- ii. 75% of Running Account Bills (RA Bills) will be paid within 5 working days on receipt of Original RA Bills and balance 25% payment will be released subject to scrutiny by PMC-TWIC. 25% balance will be released within 15 days from the date of 75% payment made by CLE.
- iii. For Bidders willing to take part in all three schedules can submit one consolidated Solvency Certificate for technical prequalification with cumulative value as per the requirement mentioned in the tender.
