# Survey on Leather & Leather **Products Sector & Evaluation of ILDP** by National Productivity Council (NPC) Workshops organized by CLE - Southern Region (October 2016)



The Department of Industrial Policy & Promotion, Ministry of Commerce & Industry, Government of India, has entrusted an assignment to National Productivity Council (NPC) for undertaking a Survey for Database Development and evaluation /appraisal of Indian Leather Development Programme (ILDP) being implemented during the current 12th Five Year Plan Period. The study comprise of two parts:

1. Involves database development of Leather and Leather Product manufacturing units (including nonleather footwear, etc)

2. Involves evaluation and appraisal of the implementation of ILDP during the 12th Five Year Plan Period i.e. 2012-2017. The sub-schemes of the ILDP include IDLS Scheme, Leather Technology, Innovation & Environmental issues, Mega Leather Clusters, HRD, etc.

The NPC, in this regard, has devised a Questionnaire for collecting inputs from all the stakeholders of leather sector i.e. all the individual units/firms engaged in all segments of the leather & leather products industry. The Questionnaire seeks inputs in the form of Primary data from all the units.

It may be mentioned here that in the absence of primary data about the number and types of firms / units and their future employment generation potential visà-vis present employment, investment requirement for upgradation of their machinery /equipment and scaling up of their potential to avail of emerging opportunities, the correct picture and the potential of the Sector cannot be projected.

As the exercise is time bound, the DIPP has desired the CLE to coordinate and render necessary assistance to the NPC in undertaking the Survey for database development and the Evaluation of ILDP. The DIPP has advised the CLE to urge its Members to respond to the Survey Questionnaire to facilitate the process of database development and evaluation of the ILDP, as further continuation /allocation of funds under ILDP is dependent upon this evaluation/appraisal being undertaken by the NPC.

The following are the intervention activities of the CLE to assist the Survey undertaken by NPC:

Considering the importance of the exercise, Shri 1. M. Rafeeque Ahmed, Chairman, CLE, has issued a Circular to Members of the Council requesting them to give primary importance to this Survey and submit their filled up Questionnaire to the NPC. This Circular was dated 7th October, 2016, which was sent to about 3400 Members of the CLE.

2. The Head Office of the CLE had interacted with the NPC Head Quarters from time to time and coordinated for organization of the Workshops to disseminate the information on the Survey to the industry.

3. Besides the CLE Head Ouarters in Chennai, all the Regional Offices of the CLE located in New Delhi, Kolkata, Mumbai, Kanpur, Agra and Jalandhar, the concerned Regional Directors have interacted and coordinate with the respective Regional offices of the NPC and coordinated in organizing the Workshops to create awareness of the Survey exercise.

4. The Workshops were organized by CLE in Ambur on 24.10.2016, Ranipet on 24.10.2016, Kanpur on 27.10.2016, Chennai on 02.11.2016, New Delhi on 03.11.2016, Kolkata on 03.11.2016 and Mumbai on 09.11.2016. The Workshop in Kozhikode was coordinated by CIFI, Kerala chapter, on the request made by the CLE.

CLE participated in these Workshops and high-5. lighted the exercise of Survey and advised the industry to submit the filled-up Questionnaire to NPC. The linkage between the Survey and the continuation of the ILDP with higher outlay was explained and the need for development of database to project the leather industry better and accurate data was also explained. The NPC officials have participated in the Workshops and made technical presentation on the Survey, content of the Questionnaire and clarified on the details sought. The industry associations in the clusters have attended these Workshops.

Based on the above intervention measures undertaken by CLE and the guidance and support extended to the NPC, the filled-up Questionnaire is being submitted by the industry units to the NPC directly.

#### WORKSHOP AT AMBUR - 24.10.2016

The Workshop at Ambur was planned with the support of Ambur Tanners Association (ATA) and South India Shoe Manufacturers Association (SISMA), which are two prominent industry associations in the Cluster. He welcomed all the participants to this Workshop and he narrated the importance of having the data updated for the Ambur Leather Cluster which will reflect the correct status of the leather industry operating in the cluster.

Shri A. Fayaz Ahmad, Assistant Director (ILDP), CLE, in his speech has informed that ILDP is one of the pivotal Schemes for the development and growth of the Leather Industry in the Country. The ILDP which is a Central plan implemented for the leather sector is being continued in each Five Year Plan Periods, getting higher outlay to aid and assist the industry in its development. The thrust of the ILDP scheme is on technology up gradation and modernization of production units, expansion of production capacities, creation of institutional facilities in the country, training Human Resources for the leather sector, support to rural artisans for design and product development, create market linkages, environment management in the tanning sector, and establishment of Mega Leather Clusters etc. In nutshell, the basic objective of the ILDP is towards industrial development of the leather sector. Since the current Five Year Plan period is coming to end by March 2017, the DIPP has entrusted the assignment to NPC to evaluate and appraise the ILDP. Further as part of this assignment, the development of database for the leather sector was also entrusted to the NPC. The generation of the primary data to build up the database for the leather sector is highly essential to know the current status of the industry, in terms of number of units functioning, their investment / capital deployed, registration under the classification of MSMEs, manpower deployed, total turnover, production capacities, capacity utilization vis-à-vis the installed capacity and other such parameters. This is an opportunity for the Leather Industry units to submit these details and respond to the Questionnaire prepared by the NPC. The CLE has already circulated the Questionnaire to the Units and Chairman of the CLE has issued this circular considering the importance of this exercise. The updated database will be useful for the CLE / Govt. of India for seeking higher allocation of funds under ILDP. The interventions of CLE in organizing the Workshops in various clusters in the country have been explained to get an idea on this nationwide campaign to build database for the leather sector and evaluation of ILDP. He concluded his presentation by requesting the participants to submit the filled up Questionnaire to the NPC.
