Tender Notice No. CLE-HO/ASIDE/CFC-M/2016-17 dated 31.1.2017

Name of Work: *Appointment of Contractor for Supply, Installation and Commissioning of Machinery and Equipment for Common Facility Centre at Melvisharam*

1. Authorisation Letter from the Principal should be produced by the bidder and included in Cover-1 Technical Bid. The supplier shall give Original Letter that he is the authorised Indian agent in the Letter Head of the Principal. The scanned copy of the document showing that the authorised representative of the Principal has participated in the Tender is acceptable, considering the paucity of time. However, the bidder should ensure that the original document is submitted before the Financial Bid Opening.
2. For bidders quoting for individual equipment, EMD should be paid as 1% of the estimated amount given in Annex 1 of Volume 1 - Instructions to Tenderers. Following Currency Exchange Rate should be adopted for computational purpose of EMD:-

1 US Dollar	=	68 Indian Rupees
1 Euro	=	73 Indian Rupees
3. It was also informed to the bidders that there shall be Main Cover in which Cover 1 - Technical Bids (along with EMD, documents called for) duly sealed and Cover 2 - Financial Bid original duly sealed shall be submitted before the deadline at CLE Head Office, Chennai duly signed in all pages affixing the seal of the company / firm with authorized signatory.
4. As it is the Duration for Delivery of the quoted machinery / equipment remain as per Tender Document.

5. As it is the Warranty Period (from Date of Commissioning) remain as per Tender Document.
6. A special payment terms of 90 % L.C for supply and 10 % L.C valid for the guarantee period of equipment may also be considered by the Council.
7. Considering the request of bidders, the Council shall provide IE code to the bidders (where required). The bidders shall indicate the Customs duty applicable separately and the Council shall pay the Duty in favour of Customs (where required) on submission of Demand notice from Customs authorities. All other charges related to Supply, Installation and Commissioning of Machinery / Equipment would be to the supplier's account.
8. Plant and Machinery, Service Plant and Accessories, Office Equipment and Safety Equipment mentioned in Volume 3 – Price Bid shall prevail.
