The Council for Leather Exports (CLE) invites sealed bids for individual items from manufacturers and/or authorised suppliers having required sales, service and warranty support for supply, installation and commissioning of machinery and equipments for CFC, Melvisharam at an estimated cost of **Rs. 17.73 Crores**. The scope of works includes, but not limited to, plants and machinery, service plants and accessories, pipe line for steam and air and associated works. For this purpose, CLE invites sealed bids in two cover system (Cover-1 Technical Bid and Cover-2 Financial Bid) from eligible and qualified bidders for the under mentioned work:
