# Two-Day Buyer-Seller Meet in Cape Town, South Africa February 21-22, 2018

#### **Introduction:**

India is a significant player in the global leather business being the second largest global producer of footwear & leather garments and fifth largest exporter of leather goods & accessories. Exports from the Indian Leather industry has grown from USD 107.97 million in 1966-67 to USD 5665.91 million in 2016-17.

Africa is the world's Second-Largest and second-most-populous continent in the world. African countries are potential markets for export of footwear (including non-leather footwear), leather accessories/goods, leather garments and finished leather. As many African countries, due to their Least Developed Country status, get Import Duty Exemption in major markets like Europe and USA, there is potential for Indian exporters to explore possibilities for Third Country Trade and for manufacturers to set-up units in Africa as Joint Ventures.

#### **India-Africa Leather Trade:**

Africa's import of leather leather products had increased from US\$3386.19 mn in 2012 to US\$4980.81 mn in 2016 growing at a CAGR of 10.13%. India's export of leather & leather products to Africa increased from US\$169.63 mn in 2012 to US\$310.74 mn in 2016-17, growing



#### at a CAGR of 16.34%

Out of Africa's total leather import trade, import by South Africa alone is to the tune of US\$978.81 mn accounting for a share of close to 20% in Africa's total leather import trade. Hence, South Africa is the largest importer of leather & leather products among the African Countries.

#### India - South Africa Leather Trade:

· South Africa is a significant market in Africa for leather and leather products including Footwear. South Africa imports to the tune of US\$9.78 bn. with a share of about 5% in the global import of leather and leather products valued at US\$180 bn in 2016. India accounts for a share of 4.53% in South Africa's total leather import trade of US\$ 978.41 million in 2016, providing ample scope to further enhance our exports to South Africa.

• India's exports to South Africa has increased from US\$ 36.07 million in 2012 to US\$ 44.29 million in 2016, growing at a CAGR of 5.27%. Footwear accounts for about 55% of India's total export of leather and leather products to South Africa followed by Finished Leather, Leather Goods & Leather Garments.

# Buyer-Seller Meet in South Africa, Feb 21-22, 2018

With a view to further promote the export of leather & leather products to South Africa, the Council for Leather

Exports in association with Consulate General of India, Cape Town, South Africa organized a Two Day Buyer Seller Meet (BSM) in Cape Town, South Africa during February 21-22,

2018 at the Cape Town International Convention Centre.

The Council has been organizing the Buyer-Seller Meet in South Africa since 2013 under the Market Access Initiative Scheme of the Government of India. The BSM organised during Feb 2018 is Fourth in this series. The past BSMs organised by the Council had evoked a positive response among the buyers resulting in large number of buyers footfall.

As per Govt guidelines, the creatives of IBEF is to be used for the Govt supported International Events. Accordingly, the Fascia Template Design for the South Africa BSM was used as per IBEF Design Options.

Potential Buyers including many major brands and buying groups like the Foschini Group, Due South (The Foschini Group), Cape Union Mart, Queenspark, Truworths, Exact (The Foschini Group), Busby Group, Green Cross Shoes, Jensen Belts, Kurgan Leather, Lopez Leathers, Kenani SPREE, Woodheads, Ivor Cohen Agencies, Barker Footwear, Europa Distributors, Footgear, Fusion Leather, HB Agencies, Jordan, Mossop Western Leather visited the BSM in South Africa organised in the last edition of the BSM during March 2017.

IMPORT DUTY- Many of the Participants informed that the Import Duties levied for leather products in South Africa are presently high and requested necessary intervention from the Council for reducing the same which would facilitate further increase in India's export of leather products to South Africa in the near future. In this regard, Dr. Ivan Meyer, Honb"le Minister for Finance, Western Cape Government, Cape Town requested the Council to submit a Representation for reduction in import tariff in South Africa, through proper Channel to place the same in the Parliament of South Africa for consideration. The Council is addressing this issue.

#### **Conclusion:**

The Marketing Agency M/s. Leaders in Trade Exhibitions, Cape Town undertook extensive Publicity and Buyer Mobilisation Campaign which included Advertisements in leading leather product magazines "Shoes & Views Magazine", E-mail and Print invites, SMS reminder campaigns targeting the database of 8000 buyers and a Press Release.

Based on the Publicity and Buyer Mobilisation Campaign undertaken by the Marketing Agency with the support of CGI, we had 262 attendees over the two day period. These include buyers from Cape Town, Port Elizabeth, Johannesburg, Durban, Pretoria as well. We had some excellent quality buyers attending mainly comprising of Importers, wholesalers, Department Stores, Brands and Buying Groups etc

Other important buyers from distributors, importers, wholesalers, manufacturers and agents included Kurgan Kenani Leather, Ivor Cohen Agencies, Barker Footwear, MTL Trading, Jordan, Skye Distribution, A Greenaways, Hi-Tech Distribution, Chamberlain Phipp, etc.

As per the feedback received from Member Exporters, around 292 business meetings were held during the two-Day BSM with Potential South African Buyers. Though some of the participants received some spot business, overall, the participants are anticipating sizeable business in the near future. The Participants have informed that South Africa is relatively an untapped market and CLE has to continue its marketing efforts to further increase our share. Some of the South African Buyers have informed that the Buyer-Seller Meet is a good platform for sourcing leather & leather products from India wherein a wide range of quality leather products matching their market requirements were displayed.
