Attention of the trade and other stakeholders is invited to the Facility Circular No.34/2018 Dt: 19.07.2018 on the above subject. After subsequent discussions with the trade and CLRI and as per consultation with Council of Leather Exports, the following revised inspection schedule of CLRI officials are made with immediate effect.

2. For the convenience of trade and the CLRI officials, it has been decided to confine leather export consignments only to three locations namely CONCOR ICD, TRIWAY CFS AND CWC MADHAVARAM CFS.
