On 28.03.2019, the Indian Delegation has visited leather cluster in Scandicci (Florence). The delegation visited SAPAF srl which is a highend luxury handbags manufacturer. SAPAF was established in Florence in 1954 from a project developed by Silvano Calistri and his wife, Valdivia. The business, family-owned for three generations, is distinguished by exclusive leather accessories that are entirely handcrafted, and artisan expertise deriving from over 50 years of experience in the sector. Sapaf has adopted a production differentiation strategy, thanks to collaboration with famous international names, collection planning for Private Labels and their own line featuring the Sapaf 1954 trademark. In 1997, SAPAF together with 15 Tuscan firms created the "100% Italian Consortium" to promote and support local production, in contrast with production relocation strategy.

The Delegation visited another unit PROPEL srl, which is one of the leading companies in the leather processing sector in Italy.
