Sub: Indian Footwear & Leather Development Programme (IFLDP) 2021-26 – Approved by Government of India - Notification & Guidelines issued – reg.

This is to inform you that the Government of India has approved the *Central Sector Scheme* **Indian Footwear and Leather Development Programme (IFLDP)** with an outlay of Rs.1700 Crores for 5 years period 2021-26. The core objective of the IFLDP is to enable creation of world class infrastructure to cater to the exports and domestic market, facilitate additional investments into the industry via modernization, technology upgradation and capacity expansion, setting up of new units, address environmental concerns specific to the leather sector, promote Indian Brands, set up Design Studios in the country etc.

The IFLDP consisted of six sub-schemes namely (1) Sustainable Technology and Environmental Promotion (STEP) – Outlay Rs.500 Crores (2) Integrated Development of Leather Sector (IDLS) – Outlay Rs.500 Crores (3) Mega Leather, Footwear and Accessories Cluster Development (MLFACD) – Outlay Rs.300 Crores (4) Brand Promotion of Indian Brands in Leather & Footwear Sector – Outlay Rs.100 Crores (5) Development of Design Studios – Outlay Rs.100 Crores (6) Establishment of Institutional Facilities – Outlay Rs.200 Crores.

The Department for Promotion of Industry and Internal Trade (DPIIT), Government of India has issued the Notification and Guidelines of the six sub-schemes. The following are attached herewith for your kind perusal.
