

COUNCIL FOR LEATHER EXPORTS INDIAN LEATHER INDUSTRY – OVERVIEW, EXPORT PERFORMANCE & PROSPECTS

- The Indian Leather, Leather Products and Footwear Industry holds a prominent place in the Indian economy. This sector is known for its consistency in high export earnings and it is among the top ten foreign exchange earners for the Country.
- The export of footwear, leather and leather products from India was to the tune of US \$ 4.87 billion during 2021-22.
- The industry is bestowed with an affluence of raw materials as India is endowed with 20% of world cattle & buffalo and 11% of world goat & sheep population. Added to this are the strengths of skilled manpower, innovative technology, increasing industry compliance to international environmental standards, and the dedicated support of the allied industries.
- The leather industry is an employment intensive sector, providing job to about 4.42 million people, mostly from the weaker sections of the society. Women employment is predominant in leather products sector with about 40% share.
- India is the second largest exporter of leather garments, third largest exporter of Saddlery & Harness and 4th largest exporter of Leather Goods in the world.
- The major production centers for footwear, leather and leather products in India are located in the States of Tamil Nadu - Chennai, Ambur, Ranipet, Vaniyambadi, Vellore, Pernambut, Trichy, Dindigul and Erode; West Bengal – Kolkata; Uttar Pradesh – Kanpur, Agra, Noida, Saharanpur; Maharashtra – Mumbai; Punjab – Jalandhar; Karnataka – Bengaluru; Telengana Hyderabad; Haryana - Ambala, Gurgaon, Panchkula, Karnal and Faridabad; Delhi; Madhya Pradesh – Dewas; Kerala – Kozhikode and Ernakulam / Cochin; Rajasthan; Jaipur; Jammu & Kashmir; Srinagar.



CRITERIA AND GUIDE LINES OF EXPORT AWARD

Consideration of Group Companies for Export Award:

The combined Export of "Group Companies" can be considered for the purpose of Export Excellence Award in all categories including the Overall Export Award on the basis of the following criteria:

- Promoters should have a minimum of 51% share in other Group Companies for claiming to be part of their group.
- The Group Companies need to apply with their claim for Overall and in different Products segments supported by a Chartered Accountant's Certificate
- The Export Award is to be considered based on Export performance only for Overall Export and in different Products segments including Footwear Components (Other than Shoe Upper) as per revised /fixed Export Slabs:

Export Slabs for National Awards:

- i) Upto Rs.100 Crores.
- ii) Rs.100 Crores. Rs.200 Crores.
- iii) Rs.200 Crores. 300 Crores.
- iv) Above Rs.300 Crores.

Number of Awards in different Products segments: OVERALL EXPORT AWARD: "Overall Exports" category there will be Three Awards viz. First Place, Second Place and Third Place

PRODUCT SEGMENTS: The Number Awards for various product segmentss will be 1st and 2nd Place only

Footwear Components (Other than Shoe Upper) i.e. Other Footwear Components and Soles: The Export Awards to Member-Exporters of Footwear Components (Other than Uppers) category to be given every year in recognition of their efforts in enhancing the export of Footwear Components (Other than Uppers). Under this category there will be two sub-categories namely:

- I. Soles
- II. Other Footwear Components

CRITERIA AND GUIDE LINES OF EXPORT AWARD

Deemed Exports:

The following documents have to be sent along with the Application Form in respect of Deemed exports:

- 1. Deemed Exports for the year 2018-19 duly certified by Banker's / Chartered Accountant
- 2. Name of the 100% EOU, Registration Number, Purchase order reference number, Purchase order date, Quantity and amount for the year 2018-19 has to be sent in separate statement.

NB: Member Companies who have opted to be considered as a Group for the purpose of the CLE Export Award will have to apply as a Group for the subject Award too.

Brand Creation Award: In each product category namely Leather Footwear, Non-Leather Footwear, Footwear Components. Leather Garments and Leather Goods (inclusive of Fashion Gloves/ Sports Gloves) and Saddlery & Harness)

There will be one Award for each of the above product category based on Top export performance. The Criteria for Brand Creation Award is as under:

- I. Brand should be self created and owned Brand.
- II. The Brand should be in existence for the last three financial years.
- III. In case of acquired Brand, the exporters should have proper legal ownership.
- IV. Should be a Brand which has exports.
- V. Should have an export of minimum Rs.5 crore (FOB value) of the Branded Products in the year 2018-19. For Harness and Saddlery sector minimum export will be Rs.2 crore only.
- VI. Brand Creation Award to be given for particular Brand of a Member Company only once in 5 years.

Women Entrepreneur Award:

One Woman Entrepreneur in each of the following product categories would be given 'Woman Entrepreneur award'.

Leather Footwear, Non Leather Footwear, Footwear Components, Leather Garments Leather Goods & Accessories, Industrial Leather Manufactures (Such as Industrial Gloves & Aprons), Fashion Gloves / Sports Gloves, Saddlery & Harness, Non Leather Saddlery & Harness

CRITERIA AND GUIDE LINES OF EXPORT AWARD

The criteria for the 'CLE Women Entrepreneur Award'

Company should have been established at least 3 years ago as on March 31,2019 and made a Net Profit in at least 2 of these last 3 years.

Last 3 Years Financial Statement duly certified by a Chartered Accountant is to be submitted.

The nominee must own shares of the Company, be the chief decision maker, and hold a senior executive title (Chairman, President, Chief Executive Officer, Managing Director / Proprietor / Managing Partner / Director/Partner in the Company.

Name of the nominee should be available in the CLE Membership Records as Chairman, President, Chief Executive Officer, Managing Director, Proprietor, Managing Partner/Director / Partner

She must be responsible for the day-to-day management and the financial bottom line of the Company.

The Export Performance of value-added products should be Rs.2 Crores and above in the year under consideration of the Award. (2019 - 20 & 2020 - 21)

The FOB Value of Exports should be certified by Bankers.

We need to restrict the Award only to New Women Entrepreneurs and not to consider the applicants who have already received the award last year


