I visited the Expo Riva Schuh and Gardabags Fairs held in Riva Del Garda, Italy during June 17-20, 2023. CLE organised the participation of a large contingent of 45 member exporters in these fairs.

The twin fairs reflected the revival of the global trade in footwear and leather sector once again, after the slowdown experienced during first half of this year. Our member participants also reported positive news on the business front.

During these fairs, I also met a cross section of industry stakeholders and discussed about ways and means to enhance exports from our sector. I had a meeting with Ms. Ms. Lucy Reece - Raybould, Chief Executive Officer - British Footwear Association (BFA) during which I discussed about BFA support for the proposed Footwear & Leather products show scheduled in UK during Sept. 11-13, 2023.



During the fair, CLE signed an MOU with Riva Del Garda Fiere Congressi, the organisers of the Expo Riva Schuh and Gardabags Fairs. The MOU facilitates setting-up of CLE collective area/ pavilion in the January 2024 to June 2025 editions of Garda fairs.

During the fair, I also had a meeting with Mr. Roberto Vago, Managing Director – ASSOMAC, Italy (Italian Machinery Manufacturers Association) and discussed about mutual co-operation.

## **Dear Members**

As members are aware, a geographical indication (GI) is a sign used on products that have a specific geographical origin and possess qualities or a reputation that are due to that origin. In order to function as a GI, a sign must identify a product as originating in a given place.

As far as leather industry is concerned, GI Status has been granted to products namely Andhra Pradesh Leather puppetry, Kolhapuri Chappal, Leather Toys of Indore, Leather Toys of Indore (LOGO), East India Leather (El tanned leather), Kanpur Saddlery and Santiniketan Leather Goods. The Department of Promotion of Industry and Internal Trade (DPIIT) recently held a virtual meeting on promotion of GI products and requested details of new products can be considered for GI status. Besides, the DPIIT also wants details of issues faced in registering GI products in overseas countries.



In this connection, we have sought inputs from members on the above issues. We have also sought feedback on enhancing exports/ domestic sales of the above GI Products, including support measures required from the Government.

One member has reported about registering Handmade Leather Journals as a GI Product. We have forwarded this request to DPIIT for consideration.

Meanwhile, I would request all members to send us the details on new products that could be considered for GI status and also feedback on measures to increase domestic sales and exports of GI products.

# BIS Meeting of Hon'ble Commerce & Industry Minister Shri Piyush Goyal with Leather & Footwear Stakeholders on 14th June, 2023 at Vanijya Bhawan, New Delhi

The Indian government, recognizing the significance of quality standards in the leather and footwear sector. introduced the Quality Control Order on September 2020. The aim of this order is to ensure that leather and footwear products meet specified quality criteria, which performance, includes durability, safety, and environmental standards. The government believes that implementing this QCO will not only improve the overall quality of products but also enhance consumer confidence and protect public health and safety.

However, the implementation of the Quality Control Order has faced resistance from certain segments of the footwear industry. Some industry representatives argue that the new regulations impose additional compliance burdens, leading to increased production costs and potential loss of competitiveness in the international market. They express concerns that the strict quality standards may hinder innovation and restrict the diversity of footwear designs available to consumers.

Additionally, there have been concerns about the practicality and feasibility of implementing the QCO across the entire industry. Smaller manufacturers, in particular, may struggle to meet the stringent requirements due to limited resources and technical capabilities. This has prompted calls for a more phased approach or tailored support

measures to assist smaller businesses in meeting the prescribed quality standards

To address the above concerns raised by the footwear industry Shri Piyush Goyal Minister of Commerce & Industry and Consumer Affairs, Govt of India called up a meeting of industry association along with DPIIT offices and BIS to engage in constructive dialogue and collaborate to find mutually beneficial solutions.

This meeting was Chaired by Hon'ble commerce & Industry Minister Shri Piyush Goyal in the presence of Shri Rajesh Kumar Singh, Secretary DPIIT, Shri Rajeev Kumar Singh Additional Secretary DPIIT, Shri Pramod Kumar Tiwari, DG BIS, Shri Arun Kumar Sinha, MD FDDI, Shri RK Jalan, Chairman CLE, Shri Puran Dawar, COA, CLE, Shri R Selvam ED CLE, Shri Rajkumar Gupta, CIFI, Shri N Mohan, M/s Kothari Group, Shri Sanjay Gupta, President IFCOMA and Shri Atul Kumar Mishra Regional Director CLE.

Dr Ajay Lal, Head of chemical division BIS gave presentation on the implementation of quality control of Leather & Footwear issued by govt. He conveyed that by 1st July 2023 19 footwear categories are being implemented while 5 categories will be decided in one months' time and will be applicable after two and half months.

Shri Rajeev Singh Thakur conveyed that "Despite the resistance, it is crucial to acknowledge the government's intent behind implementing the Quality Control Order. By ensuring that leather and footwear products conform to established quality benchmarks, the government aims to bolster the reputation of Indian leather and footwear in the global market, foster consumer trust, and strengthen the industry's position in the long run".

Following points were discussed and raised by Industry members before the hon'ble minister:

I. Government should consider providing assistance to smaller manufacturers through capacitybuilding programs, access to affordable technologies, and financial support to alleviate the burden of compliance. This targeted support can facilitate the industry's adaptation to the new quality standards and help them remain competitive while upholding the intended goals of the Quality Control Order

2. Industry highlighted that QCO implementation are intended to enhance product quality and consumer satisfaction, they may also have implications for inventory management within the footwear industry. One possible impact of quality control measures is an increase in unsold inventory levels within the industry.

3. Industry further clarified that the presence of excess inventories can have several implications for footwear manufacturers and retailers. Firstly, it ties up financial resources as capital is invested in unsold products. Additionally, excess inventories may lead to increased warehousing costs, as more storage space is required to accommodate the surplus products.

Shri RK Jalan Vice Chairman CLE conveyed that council as a whole we

welcome the QCO which was much awaited and this order will be game changer for the Indian footwear manufacturers and exporters. He highlighted the role of standards in helping the industry to become more competitive and how the image of India as quality manufacturers hub is growing.

Shri Puran Dawar President AFMAC also supported the QCO implementation for footwear sector and congratulated minister on implementing the QCO.

Hon'ble Minister for Commerce & Industry in his speech and interaction during the meeting conveyed that Quality Control Orders for the leather & Footwear industry will be a game changer. He further added that the QCOs will establish the brand of India and enhance the value of Indian products. He also applauded that the Industry leaders from various Leather sector associations and welcomed the Quality Control Orders (QCOs), that they will be now be working towards adoption of QCOs.

Shri Goyal engaged in discussions with stakeholders regarding the introduction of Quality Control Orders (QCOs) on a selection of 24 footwear products starting from July I, 2023. The Minister, along with the participants, explored effective strategies for the implementation of these QCOs. Emphasizing the importance of adhering to the QCOs, the Minister declared that they would be enforced rigorously from July I, 2023, for the designated 24 products.

However, in consideration of 5 standards that have recently undergone revisions, manufacturers producing goods according to these updated specifications will be granted an additional 6-month grace period to ensure compliance with the QCOs, commencing from January 1, 2024. Furthermore, the implementation of the QCOs will be phased for small-scale industries, starting from January 1, 2024, and for micro-scale industries, commencing from July 1, 2024.

Shri Piyush Goyal urged the Indian industry to collaborate with the Bureau of Indian Standards (BIS) in formulating standards for products that currently lack such specifications. This initiative would enable these products to be included under the Quality Control Orders (QCOs) six months after the notification of the standards. The Minister also announced a significant reduction of 80 percent in testing charges for footwear products under the QCOs specifically for Certified Start-ups and micro industrial units.

Furthermore, Shri Goyal made an important announcement that starting from next Monday, June 19, 2023, BIS would allocate one hour on every working day for interactive video conference sessions. This platform would allow stakeholders to engage with BIS, address queries, and report complaints. The Minister instructed Shri Pramod Kumar Tiwari, the Director General of BIS, to widely publicize this arrangement and ensure the timely registration and response to all queries and complaints.

The Minister appealed to the Indian industry to effectively implement the Quality Control Orders and manufacture and supply footwear of high quality, as prescribed by the Indian Standards, to consumers. He stressed the significance of quality and consumer satisfaction in driving the economic growth of the country. Shri Goyal urged all stakeholders to collaborate in strengthening the quality ecosystem in the nation and meeting the needs of consumers.

## **IN BRIEF**



## Confédération Européenne de l'Industrie de la Chaussure European Confederation of the Footwear Industry

On 1st June 2023, the European Parliament adopted the Report on an EU Strategy for Sustainable and Circular Textiles (EU Textiles Strategy). The European Footwear Confederation (CEC) welcomes such initiative aiming at a more sustainable industry in full compliance with international human, labour and environmental standards all around the globe. European footwear companies are committed and working in this direction; however, it is also essential that such parameters are respected by non-EU partners, and for that the European Commission needs to ensure the necessary measures in cooperation and trade agreements with third countries.

First of all, we wish to point out that since the establishment of the textiles ecosystem in March 2020 within the "New Industrial Strategy for Europe", the term "textiles" has generated confusion and misinterpretation of the specific sectors covered by this term, namely textile, clothing, leather and footwear (TCLF) sectors, and to the tendency to look for "one-fits-all" solutions. When it comes to footwear, the product is often excluded or assimilated to textile and apparel, and consequently subject to the exclusion or inclusion in the scope of several initiatives, without a proper assessment of the feasibility.

The Report voted yesterday is an example of the ongoing legislative trend. On a technical basis, the document does not consider the peculiarities in health and safety standards, number of materials, production processes and waste management between the different products within the scope of the Strategy and, consequently, intends to provide common, but unfeasible, solutions. Moreover, it also lacks in solutions for a strengthened resilience and competitiveness, threatening the recovery of the EU industry.

For what concerns the EU footwear industry, some elements of the text should be revaluated in order to ensure concrete and feasible results during this green transition, not leaving anyone behind. For this reason, the CEC would like:

• To underline, as already expressed in several other occasions, that footwear is a complex product composed by a multitude of materials and components, assembled with different techniques, subject to specific health and safety standards and requiring specific recycling and circularity models. Therefore, the aggregation of footwear and textiles, and the definition of horizontal require-

# PEDIATRIC GAIT ABNORMALITIES - Rotational Problems

#### Introduction

Gait is the dynamic result of the interaction of the neuromuscular and skeletal systems. Many of the pediatric gait abnormalities can occur due to the following conditions. i.e. neuromuscular disorder, deformity in lower extremity. While many pediatric gait abnormalities can be followed and treated conservatively, some gait abnormalities require a more comprehensive approach to evaluation and treatment. The intent of this article is to give a greater understanding about the gait development in children and also about some of the major gait abnormalities present in children.



#### **Common Gait Abnormalities in** Children:

Gait abnormalities are complex and often include deviations at multiple joints and in multiple planes of motion. Common variations include rotational problems (in-toeing, outtoeing), angular problems (genu varum [bowlegs], genu valgum [knockknees]) and muscular dystrophy. The normal range of rotation of the foot, leg, and hip includes measurements that fall within two standard deviations of the mean. A variation becomes a deformity when the amount of deviation from normal for that particular age is more than two standard deviations. For example, normal external hip rotation for a five-year-old child is between 30 and 65 degrees. Those with hip values outside this range are said to have a deformity.

#### **Rotational problems**

#### In – Toeing:

An in-toeing gait is very common in children. In fact, an in-toeing gait (pigeontoed) is the most common rotational deformity seen in pediatric orthopedics.

In-toeing usually doesn't cause pain or prevent a child from learning to walk or run and often corrects itself. Most children's feet gradually straighten out as they grow older and their walking and running improves. If the condition continues and is left untreated, it can lead to complications including:

- · An unbalanced gait (way of walking) that can cause strain
- Reduced athletic ability because of problems running and jumping
- · Foot deformities including bunions, hammertoes and flat feet

#### Causes of In – Toeing:

- There are different causes for in-toeing depending on where the legs or feet are misaligned:
- · Curved foot (metatarsus adductus), which is usually present at birth
- Twisted shin (tibia torsion), the most common cause of intoeing, which occurs around age I to 3
- Twisted thighbone (femoral anteversion), which occurs around age 3 to 8


The exact causes for these foot and leg problems are not certain, but medical experts suspect that it may be related to:

- · Family history of intoeing
- · Cramped position in the uterus

#### Corrective Measures for In-toeing in children:

In-toeing usually corrects itself without treatment in almost all children. However, the pediatrician may recommend treatment if the child develops severe problems. There are different options depending on the cause of the in-toeing, including:

• Serial casting - The pediatric podiatrist places a series of casts, each one with foot held straighter than the prior cast until the deformity is resolved. Effective from about 6 weeks of age through about 14 months.






•Wheaton brace - This commercial brace can be used to treat Metatarsus Adductus and Internal Tibial Torsion. It is effective from about 6 months through age 2.

• **Dennis Browne splint** - this is the old fashion bar affixed between shoes that infants sleep with at night.



• **Surgical treatment** - Surgical treatment may be required for severe cases or if correction is not achieved by the non-surgical treatments listed. The conservative treatments are generally effective if utilized early when the joint of the foot are developing and "malleable." In Surgery the shinbone or thigh bone is realigned.

"All foot anthropometric studies clearly indicate that the Right and Left Foot dimensions are the same for a majority of the population.

Only in a minority of the population is there a difference in the foot dimensions between the Right and Left foot."

**Dr Gautham Gopalakrishna, Former Chief Scientist, CSIR-CLRI** says "Since this Survey was for the majority of the population only NORMAL Foot were considered and therefore it was enough if only ONE Foot (the RIGHT FOOT in our case) was considered for Scanning.

If a Survey was being done for including ABNORMAL Foot or if a CUSTOMIZED Footwear was to be developed then we would have measured the foot of the people which had differing Right and Left Foot dimensions."

"A Library of Lasts for different shapes (Sports. Formal, Casual and other shapes) is important" says **Mr Ramesh Subramaniam, Industry Expert**. We may study the data of the scan trials of both foot of at least four persons and develop the lasts, he added.



**Dr. Ferenc Schmél from TECHNORG, Hungary** said that in a statistically significant survey the robustness of the survey as well as the results of the interpretation are very well represented by the "NORMAL DISTRIBUTION i.e. the GAUSSIAN DISTRIBUTION" where the AREA under the BELL-SHAPED CURVE is considered for conducting the survey.

We asked **Mr Graham Burns of ATOM SHOEMASTER, United Kingdom** and he says "The difference that is acceptable on foot length between right and left is 2 to 3 percentage. Also, both foot measurements cannot be the same worldwide.

We also hear **Dr D Suresh Kumar, Scientist, CSIR-CLRI & Co-PI** explaining that "This project aims to study the difference between a person's right and left foot measurements. For this purpose, the foot is measured using sophisticated 3D foot scanner. The 3D foot scanner captures the entire foot in 3D and generates about 29 measurements. The captured 3D foot image can also be exported in universal 3D file format, so that any further study can also be performed."

Dr SN Jaishankar, Chief Scientist & Head, Polymer Lab and Project Head, Next Gen Footwear Projects led the 3D 'foot scanning' of both foot in the august presence of Dr PThanikaivelan, Chief Scientist; Dr M Sugunalakshmi, Chief Scientist & Dr Debasis Samanta, Principal Scientist on Wednesday, 7th June 2023 at CSIR-CLRI. A total of 162 measurements have been taken.



#### Custom fit footwear - a short story:

Previous to the 1900's, before the days of mass production, everyone had their shoes made by the local shoe maker on their own personalized wooden mould called 'shoe lasts.'

We found a difference in length in one of the measurements taken There is a half size difference between the left foot and the right foot. And not only the length, there is also a difference in the width. Such differences lead us to CUSTOMIZATION.

'Development of Indian Footwear Sizing System.'


As no scientifically derived 'Footwear Sizing System' exists in India, it was imperative that an 'Indian Footwear Sizing system' be developed based on the Foot Dimensions of the Indian feet. This is essential because footwear made on adapted English Sizing system that is being followed in India can never be comfortable for our feet as they have characteristics very different from the English feet. Hence, we embarked on a Project and successfully captured the foot data, statistically analysed the data and evolved the 'Footwear Sizing System' for the Indian feet.

A foot measurement survey is a research programme based on taking samples of the target population and carrying out anthropometric investigations on their feet. It has a statistical character since it is impossible to measure each and every person.

In a vast country like India it is important to identify the locations of the survey which are truly representative of the feet of the Indian population and account for all social, biological, ethnic and geographical variables and also factor in the Urban and Rural representation.

Consequently, the country was zonated into FIVE GEOGRAPHIC ZONES: NORTH ZONE, GANGETIC BASIN ZONE, NORTH EAST ZONE, WEST ZONE, SOUTH ZONE

It was also necessary to represent the entire population of the country from Children to adults and therefore the survey population was spilt into the following Age and Gender Groups:

For a very ROBUST Survey and for better Statistical correlation it was decided that a total of I Lakh feet measurements (Actual Measurements taken: 1,01,880 Foot Measurements) would be taken pan India.

A unique 8 DIGIT BARCODING system was devised to identify and track the subjects being measured pan India.

The Foot Measurement Technology that was used is the most advanced "3D Digital Imaging" technique which comprised of a "3 Dimensional Foot Scanner" which scanned the foot form and the anatomical landmark points and measured automatically over twenty five foot measurement parameters through an optical laser scanning system.



- The Foot Measurement Survey was carried out at 79 Locations pan India which was identified by the NSSO, Ministry of Statistics and Programme implementation, Government of India.
- Foot Data was captured at all of these Locations from various Schools, Colleges, Factories and Housing Societies in five groups: Infants & Children, Boys & Girls in ages 4-11 years; Teenage Girls from ages 12-18 years; Teenage Boys in ages 12-18 years; Maids and Women from ages 19-55 years and Youth and Men in ages 19 to 55 years.

The scan data was captured as a cloud point data and was saved and exported to the Statistical Software for further Statistical investigations.

## DATA EXTRACTION AND STATISTICAL ANALYSIS

• This is the most important stage of the project where: the data collected pan India was extracted into a 'MASTER DATABASE'. Thereafter, the extracted data was statistically analysed using very sophisticated Statistical Techniques and Advanced Algorithms to arrive at the Indian Footwear Sizing System.

## The OUTCOMES that we arrived at were:

- Different Length and Width Groups required for the Indian Population
- Specification of the Last Grading parameters: viz. the Length and Width increments required
- Equivalence with other sizing systems followed internationally viz. English Sizing System and French Sizing system which led us to establish the new Indian Footwear Sizing System i.e. IS 1638 - 2023.





ECHA has published the restriction draft on bisphenol A (BPA) and other bisphenols of similar Concern (BosC). The restriction draft foresees that after finalization the leather industry needs to reduce BosC traces to 500 mg/kg or less towards the end of 2030. Afterwards the BosC level needs to be reduced to 10 mg/kg or less. There are a few points in the restriction draft that will need further clarification and as such the restriction text may change to some extent before finalization.

# **Quality Control Orders (QCOs) implementation for Footwear Sector, coming into effect from 1st July 2023**

The Department for Promotion of Industry & Internal Trade, Ministry of Commerce & Industry, Government of India has mandated the Quality Control Orders [QCOs] for Footwear Sector which will come into force with effect from Ist day of July 2023. The Bureau of Indian Standards (BIS) shall be the certifying and enforcing authority for the goods or articles. The following goods & articles are notified under QCOs: i.e., the following goods shall conform to the Indian Standards and shall bear the Standard Mark under a license from BIS:

In the above-mentioned two Orders dated 03.06.2022, it is mentioned that the QCOs for the Footwear Sector shall not apply to goods or articles meant for exports.

Vide Order dated 11.08.2022 issued by DPIIT, Govt of India, it is mentioned that QCOs for Footwear Sector shall not apply to micro and small manufacturing units as defined in Section 7 of the Micro, Small and Medium Enterprises Development Act 2006 (27 of 2006) as amended from time to time.

As per Ministry of MSME, Govt of India Notification dated 26.06.2020, an enterprise shall be classified on the basis of the following criteria namely:

- (i) a micro enterprise, where the investment in plant and machinery or equipment does not exceed Rs. I Crore and Turnover does not exceed Rs.5 Crores.
- (ii) a small enterprise, where the investment in plant and machinery or equipment does not exceed Rs.10 Crore and Turnover does not exceed Rs.50 Crores.

## **Provisions / Applicability**

- BIS shall be the certifying and enforcing authority for the goods or articles.
- The goods & articles notified under QCOs shall conform to the Indian Standards and shall bear the Standard Mark under a license from BIS.
- From 1st July 2023, notified Footwear Products cannot be imported / sold / traded in domestic market, without a BIS license.
- Footwear manufacturers dealing in notified footwear products, have to submit their applications for getting the BIS registration/license, in the online portal of BIS www.bis. gov.in

 For import of notified items into India, the foreign manufacturers have to prior apply and obtain the BIS License without which imports into India will not be permitted. For this purpose, BIS is operating Foreign Manufacturers Certification Scheme (FMCS) under which BIS License is granted to foreign manufacturers for use of Standard Mark on a product that conforms to an India Standard.

## Press Information Bureau (PIB) Press Release issued, after the Meeting of Hon'ble Minister for Commerce & Industry on 14.06.2023.

As per PIB Press Release, the following are the key points:

- QCO shall come into effect for small scale industries from 01.01.2024 (6 months extension)
- QCO shall come into effect for micro scale industries from 01.07.2024 (1 year extension)
- For 5 Standards (revised recently), manufacturers making the products as per these revised specifications will be given an additional time of 6 months to comply with the QCOs with effect from 01.01.2024.

Industry Outreach Dissemination by Council for Leather Exports (CLE)

- CLE has prepared a Note on the QCOs, and various actions taken by the authorities concerned and published the same in the CLE in-house magazine Leather News India, which gets circulated to all the footwear and footwear components manufacturers in the country (those who are registered with CLE). Leather News India is also a public document in the CLE website, accessible to all the public / browsers.
- CLE has prepared a Note on the QCOs, brief information on the products covered under QCOs, procedures for filing applications for registration of notified products, BIS process for grant of license, testing facilities and contact details of the BIS officers across the country. This Note along with Notifications issued by the DPIIT, Govt of India, was circulated to all the units registered with CLE vide circular dated 11.05.2023.
- All the above relevant details were hosted in the CLE website www. leatheindia.org and kept in public domain. These can be accessed from homepage itself.

## Industry Outreach Events (Webinars) conducted by CLE.

CLE conducted Industry outreach Events (Webinars) on 18.05.2023 in which officials of BIS participated and explained the Implementation aspects of the QCOs with respect to the procedures to be followed by the industry, applications, documentations, testing, grant of license etc and also on the imports of footwear and components from abroad, procedures to be followed under the Foreign Manufacturers Certification Scheme (FMCS), applications, documentations, methodology etc. A total of 109 manufacturing units of footwear and footwear components comprising 286 participants attended this webinar on 18.05.2023. Industry Associations namely Confederation of Indian Footwear Industries (CIFI), Fraternity of Agra Footwear Manufacturers (FAFM), Agra Footwear Manufacturer's Association, Agra Shoe Factors Federation participated in this webinar.

CLE conducted another Industry outreach Event on 21.06.2023 in which officials of BIS participated and explained the procedures. 47 manufacturing units of footwear and footwear components comprising 125 participants attended this webinar. 22 Units were repeat participants. Industry Associations namely Indian Shoe Federation (ISF), Agra Footwear Manufacturers and Exporters Chamber (AFMEC), South India Shoe Manufacturers Association (SISMA) and Indian Footwear Components Manufacturers Association (IFCOMA) have participated in this webinar.

# CLE organizes Industry Outreach Event (Webinar) on Quality Control Orders (QCOs) implementation in the Footwear Sector on 21st June 2023

The Government of India has notified the Quality Control Orders (QCOs) for Footwear Sector which will come into force from 1st day of July 2023. The Bureau of Indian Standards (BIS) shall be certifying and enforcing authority for the goods or articles. 10 items of Footwear made of Leather and Other Materials, and 14 items of Footwear made from all rubber and all polymeric materials, and its components are coming under the OCO. The OCOs for the Footwear Sector shall not apply to goods or articles meant for exports. It is also mentioned that QCOs for footwear sector shall not apply to micro and small manufacturing units (MSEs). From 1st July 2023 onwards, notified Footwear products cannot be sold / traded in domestic market without a BIS License. The products would have to conform to the specified standards and bear the standard mark under a license from the BIS.

The implementation of Quality Control Orders (QCOs) for Footwear Sector is critical subject importance to the industry of on the implementation aspect of the QCOs, with respect to the procedures to be followed by the industry, applications, documentations testing, grant of license etc. It may be recalled that Council for Leather Exports (CLE) has organized the Ist edition of Industry Outreach Event on QCOs on 18th May 2023. In continuation to this, the CLE has organized the 2nd edition of Industry Outreach Event (Webinar) on the QCO implementation on 21st June 2023 (Wednesday) @ 11.30am. The officials of Bureau of Indian Standards (BIS) participated in the Webinar.

The Webinar was presided over by Shri Sanjay Leekha, Chairman, CLE, and Shri R Selvam, IAS, Executive Director, CLE. The prominent participants include Shri M Israr Ahmed, Regional Chairman (South), CLE, Shri Panaruna Aqeel Ahmed, the immediate past Chairman of CLE.

The officials of Bureau of Indian Standards - Shri Aditya Das, Scientist D, Shri Amit Choudhary, Scientist D, and Shri Pravir Kumar Choubey, Scientist have participated in the webinar. A total of 54manufacturing units of footwear and footwear components comprising 125 participantsattended this webinar. 22 manufacturing units participated for the second timeas they have already participated in the Webinar held on 18th May 2023. The Region-wise participations consists of Southern Region (23 units), Northern Region (9 units), Agra (13 units), Central Region (6 units) and Western Region (3 units). Prominent footwear brands attended the webinar to name a few Walkaroo, Fengtay, Relaxo etc. Shri A. Fayaz Ahmad, Deputy Director, CLE has coordinated the industry outreach event with the industry and BIS.

Industry Associations namely Indian Shoe Federation (ISF), Agra Footwear Manufacturer's & Exporters Chamber (AFMEC), Indian Footwear Components Manufacturers Association (IFCOMA) and South India Shoe Manufacturers Association (SISMA) participated in this webinar.

Shri R Selvam, IAS, Executive Director-CLE welcomed the participants, and thanked the officials of Bureau of Indian Standards for joining this webinar. He informed that this interaction meeting is being held after the meeting of Hon'ble Union Minister for Commerce &Industry, Consumer Affairs, Food & Public Distribution and Textiles, Government of India, held on 14.06.2023 with BIS, DPIIT and Industry Stakeholder Organizations etc. The outcome of the meeting had already been published in the newspaper and PIB has issued the Press Release. In today'sIndustry Outreach event also, officials from BIS Shri Aditya Das, Shri Amit Choudhary, and Shri Pravir Kr Choubey, have joined to interact with the industry. To brief the major discussion points during the meeting was as follows: -

- Small scale sectors i.e., having turnover not exceeding Rs.50 Crores have got exemption till 31st December 2023.
- The micro sector has got exemption till 30th June 2024.
- The exemptions for all the sectors will be removed from 1st July 2024.
- For 5 Standards (revised recently), manufacturers making the products as per these revised specifications will be given an additional time of 6 months to comply with the QCOs with effect from 01.01.2024.

Above stated are the broader outcome of the meeting held with CIM. Additionally, the Bureau of Indian Standards will start one hour discussion every working day from 10.00am to 11.00am, the DGBIS has also agreed and subsequently they had issued a notification for online discussions. At present, to implement the Indian Standards, there are a total of 10 laboratories recognized by BIS which are I Lab of FDDI, I Lab of CLRI & 8 Labs of the private sector have been approved. So in total 10 recognized laboratories all over India have been approved by BIS for implementing these standards. The most important part in the review meeting held under the chairmanship of Hon'ble Minister, the number of applications received from BIS side was very low, which shows that the industries still have not applied for BIS Certification, which was noted on that day. He informed that all the industries falling under the QCO notifications should apply for the BIS certification and follow the Indian Standards (IS).

Shri Sanjay Leekha, Chairman, CLE in his keynote address has thanked participants, the BIS officials for taking part in this webinar, and the Institutions present at the meeting. The meeting under the chairmanship of Hon'ble Minister of Commerce & Industry held last week has put to rest many of the queries and the major issues were clearly clarified & said that we are here to ensure that the BIS Standards are implemented as per the schedule. Chairman requested all the industry members to work very proactively on these and kindly get their labs certified, as many of the members here have to get their own labs certified from BIS at the earliest or otherwise have to find other solution that how the Common Facility Centers(CFCs) or Cluster Labs can be used. He informed that he is confident that BIS will give all the support and handholding that requires.

Shri Amit Choudhary, Scientist D, Central Marks Department of BIS, has made a presentation on Footwear – BIS Certification and explained about the history of BIS, BIS Act 2016, Quality Control Order on Footwear Products,

recognized a have been procedure to be followed under the foreign manufacturers Certification Scheme (FMCS), methodology etc.

Thereafter, discussion forum opened with Question and Answer (Q&A) session was held in the webinar, and participants have interacted with the officials of BIS and queries raised by the participants were explained by the BIS officials which were mostly on the BIS Certification for the old versions and switching over to new versions (wherever applicable), categorization of the Indian Standards (IS), amendments on the categorization for reducing the implementation issues, BIS product certification process, laboratory requirements etc.

The Press Release is available in the public domain and as per this, QCOs will be implemented in letter and spirit with effect from 1st July 2023 for the 24 notified products. He then thanked all the Industry Associations for joining this webinar. For any subsequent developments on the QCOs, CLE will keep the members informed. He also informed that CLE would continue to organize such Industry Outreach Events in future periods as well and will provide platform to the industry to interact with the BIS on matters concerning the QCO implementation in footwear sector.



ments, are neither feasible nor appropriate from both the ecodesign and circularity perspectives.

• To remind, as correctly mentioned in the Report, that the EU footwear industry consists almost exclusively by SMEs who need support and realistic practices to achieve the objectives of the EU Green Deal. In this regard, the CEC welcomes the incentive to research and innovation envisages by the EP;

• To review the EP expectations on "the considerable economic leverage" of the sector (provided that the text refers to the entire textiles ecosystem), being the latter too optimistic. The EU footwear industry is mainly focused on high added-value products not sharing the same market share of fast-fashion products, the majority of which is imported from third countries, mainly in Asia. In this regard, 89% of footwear made available on the EU market in 2022 was imported, meaning that the leverage power attributed to the EU industry is overrated;

• To invite the legislators to consider the competitiveness of EU companies and to ensure a level playing field, that includes transparency and international standards, when negotiating Free Trade agreements or granting EU GSP status. Alongside the tremendous consequences of the Covid-19 pandemic and the ongoing geopolitical scenario, EU footwear is experiencing a gradual and constant regression in both production and trade vis-à-vis its direct competitors from third countries;

• To reject the assumption that cattle are raised and slaughtered for fashion purposes. Leather is a by-product of the footwear industry obtained by the recovery of hides and skins that would otherwise been disposed. In addition, the CEC calls for the end of the market demonisation of leather;

• Last but not least, to encourage the legislators to pay more attention to the use of term "textile(s)" and to better identify which pieces of legislation are relevant for the different products covered by the EU Textiles strategy;

The CEC remains at the disposal of the legislators for further cooperation in the upcoming legislative actions.

# Leather Footwear Programme of Khadi and Village Industries Commission (KVIC)

Village Khadi and Industries Commission (KVIC) is a statutory body formed in April 1957 by the Government of India, under the Act of Parliament, 'Khadi and Village Industries Commission Act of 1956'. It is an apex organization under the Ministry of Micro, Small and Medium Enterprises, with regard to khadi and village industries within India, which seeks to - "plan, promote, facilitate, organise and assist in the establishment and development of khadi and village industries in the rural areas in coordination with other agencies engaged in rural development wherever necessary." There are many verticals under the umbrella of Village industries sector.

Khadi&Village Industries Commission is implementing the Leather Footwear Activity under Grmodyog Vikas Yojana (GVY) in order to help leather footwear artisans/beneficiaries.There are three types of projects under the Leather Footwear Activity. • 25 days footwear manufacturing residential training (free of cost) would be given to the artisans pro bono with the help of Centre of Excellence (CoE). Cost of training of one batch of 10 artisans/beneficiaries is Rs. 3,00,000/-.

Footwear manufacturing machineries worth Rs. 60,000/- is distributed to each artisan after training (after submission of own contribution depends upon the social category, ie for SC 10 %, ST 10 %, Gen 20 %, BPL 0% of cost of machines).

- One day crash course and footwear repairing toolkits of cost Rs. 3350/- is distributed to each individual artisan (without any own contribution).
- 25 days footwear manufacturing non-residential training (free of cost) would be given to the artisans pro bono at Multi-Disciplinary Training Centre, KVIC, New Delhi and Khadi GramodyogVidyalaya Kshetriya, Varanasi. KVIC is providing hand holding support to the footwear artisans (without any own contribution).
