## NOTICE – IILF CHENNAI 2025

India Trade Promotion Organisation (ITPO) will be organizing the 38th **India International Leather Fair (IILF)** at Chennai Trade Centre from February 01- 03, 2025.

2. The booking of space by private entities for participation in the exhibition will be through ITPO's online booking portal <u>https://domesticbooking.indiatradefair.com/</u>. Interested exhibitors will be required to complete the mandatory registration process through the portal. The link for online registration is also available on ITPO's online space booking portal <u>https://domesticbooking.indiatradefair.com/</u>

3. ITPO will be opening the **First Phase** of space booking for registered Indian Companies (private exhibitors) for larger **booths of size 70 sqm and above** at **3.00 PM on December 05, 2024** (**Thursday**). Bookings will open on first-come, first-served basis through online booking portal <a href="https://domesticbooking.indiatradefair.com/">https://domesticbooking.indiatradefair.com/</a>

4. In the first phase of booking for larger booths (70 sqm and above), registered Indian applicants will be allowed to choose their booths online and make payment through RTGS/NEFT within 07 days of the opening of online booking, i.e. **till 6.00 PM** on **December 12, 2024 (Thursday).** Each company will be allowed to **select a maximum of 02 booths.** 

5. Details of the bank account will be available at the time of booking. In case payments are not received in ITPO's bank account by **6.00 PM** On **December 12, 2024**, the booths selected by the applicant will be cancelled.

6. Second Phase (for booths under 70 sqm) of bookings for smaller booths will open soon afterwards and the exact date and time for the same will be announced on or after December 12, 2024.

7. Exhibitors interested in participating in IILF Chennai 2025 will be required to comply with the terms and conditions, rules and regulations, exhibitor manual, notices, etc. issued from time-to-time.
